GENERAL RELEASE. The undersigned hereby releases and waives any claims the undersigned may now or hereafter have against the equestrian facility NEWTON COUNTY FFA ARENA/HEARD COUNTY ARENA, Equestrian activity sponsor(s), their officers, members, agents, or their assigns from and against any and all liabilities, losses, damages, costs or expenses of whatever kind of nature, including attorney's fees which the undersigned may incur as a result of any injury to the undersigned or personal property of the undersigned as a result of the undersigned's activities undertaken at said facility including, without limitations, personal injury and damages thereof including loss of income, earnings, bodily injury, pain and suffering, emotional or mental distress and any and all medical expenses. **ASSUPTION OF RISK.** The undersigned acknowledges and understands that the equestrian facility activity undertaking involves extreme risk of personal property including horses, which may result in the undersigned participation in said equestrian activities. 


